Homeowner note – Refer to the ACC Guidelines, Criteria, and Procedures

- 1) Submit a separate ACC Application Form for each modification request.
- 2) Provide a full description of the project. At minimum your application should include:
  - (1) Drawings, sketches, materials, product brochure, color samples, pictures, as applicable.
    - (a) Paint Projects <u>REQUIRED Homeowner action</u>: Paint a 3ft x 3ft sample of the body color (s), a smaller section for the trim color (s), and a smaller section for the front door for the ACC to review. Paint information is also required if requesting to paint with existing colors.
    - (b) Landscape plan if application for landscaping is relevant to project.
    - (c) Concrete Work-must match existing neighborhood driveways and sidewalks of exposed aggregate. Materials and/or tint need to be stated in the description of work.
- 3) For major modifications provide the following additional information:
  - a) A site plan, to scale that shows the exact location of modification being requested in relation to the property lines. Note distance from property lines. Show relationship of improvement to neighboring homes and/or open spaces. Site plan should also include any existing fences, decks, walkways, driveways, exterior elevations, floor plan, and detail of materials.

## Signature on the ACC application by the owner/applicant, provides acknowledgment of the following:

- I understand that construction of certain major projects may require that I obtain a City of Renton building permit. Approval of a project by the ACC does not affect or alter that requirement.
- I understand that any construction activity taken prior to ACC approval is not allowed and that, if alterations are made, I may be required to return the property to its former condition at my own expense if this application is not approved wholly or in part and that I may be required to pay all legal expense incurred if legal action becomes necessary.
- I understand that members of the Architectural Control Committee are permitted to enter on my property to make reasonable inspection of proposed construction locations.
- It is understood that I am aware of the Covenants, Conditions, and Restrictions and Architectural Controls with regard to the review process.
- The alteration authority granted by this application will be revoked automatically if the alteration requested has not commenced within three months of the approval date of this application and/or has not been substantially completed within six months.
- I understand that any approval is contingent upon construction or alterations being completed using high quality workmanship.
- I understand that if I disagree with the ACC ruling, an appeals procedure is provided directly through the Board of Directors.

Helpful hints to ensure your ACC Application is approved as quickly as possible:

- 1. Type or clearly write you application submission.
- 2. Be very clear your paint colors for each part of your house.
- 3. Do not submit an application until you are confirmed for your paint, including the front door.
- 4. Read the ACC Guidelines and CC&R's before submitting. This will give you the information you need to be in compliance.
- 5. Do not wait till the last minute for an approval.
